3. Eligibility

Applicant should be a citizen of India and should have studied class VIII onwards in the state other than Tamil Nadu. A certificate of Permanent residence in the format given in **Annexure-I** should be furnished (English version only will be accepted).

The minimum academic requirement is that the candidate must have passed in final examination of 10+2 (Class XII) or its equivalent recognized by any State Board / Central Board or any other Board (other than Tamil Nadu) accepted by Anna University, Chennai. The candidates must have studied Mathematics, Physics and Chemistry as compulsory subjects. Candidates must have studied in Other State for continuous five years from 8<sup>th</sup> standard onwards (other than Tamil Nadu) to apply under this notification.

## 4. Mode of Selection:

The selection of candidates will be on the basis of JEE (Main) 2025 All India Rank.

## 5. Online Counselling

The Counselling for admission for the academic year 2025-26 will be conducted only through Online mode. Candidates will be called for Online counselling in the order of their merit. Mere attending the Online counselling will not confer any right/claim implicit or explicit for any candidate for claiming admission. Based on the merit and communal reservation, allotment will be made. The candidates shortlisted for Online counselling will be notified in our website on 30.07.2025 (Wed).

The candidate must be ready with the details such as Marks, Percentage of Marks, Certificates, Year of Passing, Board/ Institute, Scanned image of their photograph and signature. Scanned copy of Mark sheet/ Transfer Certificate/ Migration Certificate/ Permanent Residence Certificate and Community Certificate for EWS/OBC(NCL)/SC/ST, Rank card of JEE(Main) 2025 issued by CBSE (downloaded rank card is acceptable), Aadhaar card and other relevant certificates if any, before applying online.

Candidates are advised to send the scanned copies of relevant documents (as single pdf file) mentioned below to <u>btechadmn.cecri@csir.res.in</u> with Application Number (generated during online submission of application):

Documents other than in English language should be translated by a competent authority and sent (both original version and translated English version) accordingly.

Application without any one of the relevant certificates or mark sheet will be rejected.

## 6. Registration number for admission

6.1 Application Number generated during online submission of application is the Registration Number for Admission 2025.

6.2 The Registration Number should be quoted in all future correspondence.

## 7. Procedure for submission of Application Form

The candidates shall apply only through online by logging on to www.cecri.res.in. The candidates should fill-up online application form and ensure that the application is complete and correct in all aspects before submitting the form. Once the application is submitted, it cannot be modified. Candidates are required to upload their photograph (less than 80 KB) and signature (less than 50 KB) as per the specifications. Online application without photograph and signature will be rejected. The candidates need not send the hardcopy of the online application or any other documents. Applications received other than the Online mode will be rejected.

## **Application Fee:**

Candidates are required to remit/pay application fee (non-refundable, Rs.500/- for UR, OBC(NCL) candidates and Rs.250/-for SC/ST candidates) through online mode viz. #### 8. General

#### 8.1 Note:

- If the original certificates are not in Hindi/English, duly certified translated version of Hindi/English of such certificates will be required at the time of admission.
- Certificate of category of OBC (central list), if applicable, is to be issued by the competent authority in the prescribed format and should clearly mention that the candidate belongs to Non-Creamy Layer. The certificate should have been issued on or after 1<sup>st</sup> April, 2025.
- Certificate of category of SC is to be issued by the competent authority in the prescribed format.
- Certificate issued prior to 1<sup>st</sup> April, 2025 shall not be accepted in any case.

8.2 The candidates are informed that admission given at the time of Online counselling is only provisional. In accordance with rules prescribed for admission, if they are found to be ineligible on actual verification of original certificates / particulars by the CSIR-CECRI/DOTE/Anna University, they cannot claim any right for admission or continuation of study at any stage.

Further, the confirmation of admission is subject to verification of marks / certificates by the authorities. If the mark sheet is found to be not a genuine one,

- (i) Admission is liable for cancellation at any stage of study.
- (ii) The candidate will be debarred from pursuing any course of study for a period of 3 years.

(iii) Legal action will be taken against the candidate for furnishing forged documents.

- 1. The Original Certificate should be signed by the Officer of the Revenue Department not below the rank of a Tahsildar in the District concerned or by the Block Development Officer–Cum–Panchayat Union Commissioner in the Block concerned.
- 2. The certificates should bear the stamp of the office of the Officer signing the certificate. The certifying officer should insist upon clear proof of the permanent residence of the parent or guardian of the candidate and satisfy himself of the genuineness of the residential qualification.
- 3. The State of Permanent Residence of a candidate's guardian will be taken into account only if both the parents of the candidate are not alive. The relationship of the guardian to the candidate should also be mentioned. If both the parents are alive, only the State of Permanent Residence of father should be taken into account.
